Of the 1,000 plus applications received and processed by Anchorage Project Access more than 500 patients have met the eligibility guidelines and have received care since January, 2006. Over 350 Anchorage physicians, nurse practitioners, physical

SAVING A LIFE—ACCESS STYLE

A cure cannot be attained if a patient does not seek help. In 2006 an employed but low income cook in Anchorage had a hand lesion evaluated but declined surgery because of lack of funds. He was enrolled in Anchorage Project Access and an otherwise unexpected **sarcoma** was removed. This lesion is highly lethal and further delay would have jeopardized his life. Although the first five year landmark has not yet passed, this young man continues to work (using both hands) and demonstrates how life saving healthcare may only be sought in time with the help of a community based access system.

DID YOU KNOW?

LabCorp has agreed to match your volunteer care for Anchorage Project Access patients. Contact Chervl Gonzales at Lab-Corp at (907) 748-2787 to complete a one-time Indigent Discount Agreement. After that, you simply need to include this note on any APA lab requisitions: "Anchorage Project Access-100% discount." LabCorp, in turn, will match the 100% discount.

If there's someone you know that you think would be eligible for APA, have them call our office. It might be the person who does your hair, your dog walker or your favorite fast-food waiter. Many minimum wage employees cannot afford health care and simply put it off in order to make ends meet.

PATIENT ELIGIBILITY GUIDELINES

- Must be a Municipality of Anchorage resident
- ♦ Have no medical insurance of any type
- ♦ Gross household income at 200% or less of FPL
- Have a current medical need
