BOARD MEMBER PROFILE: KATHIE BETHARD



Kathie obtained a BS in economics in 1967 from UCLA and went to work in the IBM data center for 5 years. She also taught adjunct classes at USC in programming for 3 years.

Along with her husband Frank and their new baby boy, Kathie moved to Anchorage in the summer of 1971. She began contract work with Alaska Mutual Bank designing and writing a Mortgage Loan System to replace their manual posting ledger cards.

In Anchorage, Kathie became involved in youth hockey and soccer and served on the board of directors for the Anchorage Hockey Association for 6 years and also as president for two years. Following, she served on the board of directors of the Alaska All Star Hockey Association for ten years and was on the founding board of directors for the University of Alaska Seawolf Hockey Blueliner Club for nine years and as president for two years. Kathie organized the Minor Officials for UAA hockey for the past 20 years and continues to serve in that capacity.

Kathie was a member of the Anchorage Organizing Committee (AOC), a group of local business professionals and politicians formed to bring the winter Olympics to Anchorage. She co-chaired the World Junior Hockey Tournament sponsored by the AOC during 1989. Following, she was on the organizing committee for the Special Olympic World Games which Anchorage hosted in 2001.

Upon going to work for Providence in 2002, Kathie worked in the Refugee Program and assisted the Providence IT Department sponsor new families. She became a member of the Mission Council, a volunteer group for Providence employees who organized various community benefit programs.

Kathie's strong belief in "community" contributed to her being such an outstanding board member for Anchorage Project Access where she has served since 2012.

Giving back to her community is what makes her happy. And, as a testament to Kathie's spirit of "community," her children have carried on her commitment by volunteering for the youth of Anchorage.
